

UCSC EMPLOYEE HOUSING APARTMENTS APPLICATION

Rental rates include: rent, refuse collection, common area utilities, groundskeeping services, and repairs and maintenance of the Laureate Court complex. Tenants pay for their own utilities (i.e., electricity, gas, water, telephone and cable services). A \$1,500 security deposit is due upon an applicant's acceptance of an offer to rent an apartment. The deposit is held during the period of tenancy and is fully refundable in accordance with the terms and conditions of the rental agreement. Dogs are not allowed, but cats are permitted with an additional \$500 security deposit.
